# WORLD KNOWLEDGE FORUM 2025

Following the 1997 Asian financial crisis, the World Knowledge Forum (WKF) was founded in October 2000 after two years of preparation with the ambition to transform Korea into a knowledge-driven nation. Since then, the World Knowledge Forum has served as a platform for active discussions aimed at narrowing knowledge gaps through knowledge sharing, and fostering balanced global economic growth and prosperity.

A total of approximately 6,058 global speakers and 66,022 attendees have participated since the inaugural forum in 2000, held under the theme of 'Shaping the New Millennium with Knowledge.' The WKF has since grown into one of the largest knowledge-sharing events worldwide. Prominent speakers at previous WKFs have included state leaders such as George W. Bush, the 43rd President of the United States; Theresa May, the 76th Prime Minister of the United Kingdom; Nicolas Sarkozy, the 23rd President of the French Republic; and Gerhard Schröder, the 7th Chancellor of Germany. Presidents of international organizations have also participated, including Jim Yong Kim, the 12th President of the World Bank. Founders and CEOs such as Bill Gates, Co-founder of Microsoft Corporation; Larry Ellison, Chairman and CEO of Oracle Corporation; John L. Hennessy, Chairman of Alphabet; and George Soros, Chairman of Soros Fund Management, have graced the forum. Scholars including Larry Summers, Paul Krugman, Michael Porter, and Gregory Mankiw have also addressed the forum.

Celebrating its 26th year, a wide range of discussions will take place under the theme “New Odyssey: Navigating the Great Transition.”

**Justin Trudeau**  
The 23rd Prime Minister of Canada

Serving as the 23rd Prime Minister of Canada from 2015 to 2025, he led reforms including strengthening the middle class and forming a gender-balanced cabinet leading the country through an era of global challenges.

Trudeau entered politics in 2007 and led the Liberals to a historic majority in 2015 with his government taking bold action on many issues like climate change and poverty. He delivers powerful insights on building bridges to cultivate resilient communities and drive meaningful, lasting change.



**Jared Diamond**  
Author of “Guns, Germs, and Steel”  
Emeritus Professor at UCLA

Renowned as one of the greatest intellectuals of our times, he has written numerous best-selling books on anthropology.

He has received the U.S. National Medal of Science, the Pulitzer Prize for Nonfiction, the Tyler Prize for Environmental Science, and has been elected to the U.S. National Academy of Sciences. Beginning his research career in physiology, he expanded his work into ornithology, evolutionary biology, and biogeography. As an explorer, he rediscovered the Golden-fronted Bowerbird on a remote Pacific island. Diamond is renowned as a global intellectual, offering profound insights into modern civilization and environmental issues.



**Donald Trump Jr.**  
Executive Vice President at the Trump Organization

As Executive Vice President of the Trump Organization, he is focused on expanding the company’s real estate, retail, commercial, hospitality, and golf businesses, gaining recognition as a leading young business leader and innovator today.

Since joining The Trump Organization in 2001, Donald Jr. began his career with the Trump Place redevelopment in New York City, one of Manhattan’s largest and most successful projects. He later led developments including Trump Park Avenue, Trump International Hotel & Tower in Chicago, and Trump International Hotel in Las Vegas. Donald J. Trump Jr. returns to the World Knowledge Forum for the first time in 15 years, since 2010.



**Martin Eberhard**  
Co-founder of Tesla

Co-founder of Tesla, who sparked the electric vehicle revolution, and a serial entrepreneur who founded several companies in the IT and battery industries.

He played a pivotal role in changing public perception of electric vehicles from slow and clunky to fast, innovative, and future-oriented transportation. After leaving Tesla, Eberhard contributed to Volkswagen’s electric vehicle development and served as chairman at SF Motors and InEVit. He currently advises various companies and lectures globally on reducing carbon fuel use, the benefits of electric propulsion, and entrepreneurship. Eberhard earned a BS in computer engineering (1982) and an MS in electrical engineering (1984) from the University of Illinois Urbana-Champaign.



**Charles Michel**  
Former President of the European Council

Served as President of the European Council from 2019 to 2024, setting the core agenda for the European Union.

He led large-scale recovery plans to overcome COVID-19 and, following the outbreak of the Russia-Ukraine war, coordinated immediate assistance to Ukraine from various European countries. Throughout his political career, he has consistently promoted Europe’s strategic autonomy within the global order and emphasized the need for innovation and unity to maintain the EU’s global influence. With his diplomatic skills in smoothly resolving conflicts, he advanced discussions on EU enlargement, aiming to integrate Eastern European countries into the European community. In 2014, he became the youngest prime minister in Belgian history.



**Robert F. Smith**  
Chairman of Vista Equity Partners

Head of the world's leading private equity firm investing particularly in artificial intelligence (AI) and software.

Vista Equity Partners manages over \$100 billion in assets and has built a diverse portfolio of technology companies, serving millions of customers worldwide. Smith oversees the firm’s core investment strategies and capital raising, and is an active member of its key investment committees. Since founding Vista in 2000, he has supervised more than 600 transactions with a cumulative value exceeding \$315 billion. Known for his innovative investment approach and leadership, Smith was named one of Forbes’ 100 Greatest Living Business Minds in 2017. He earned a bachelor’s degree in chemical engineering from Cornell University and an MBA from Columbia Business School.

**Nazir Razak**  
Chairman of Ikhlas Capital  
Former Chairman of CIMB

A leader who has been at the forefront of the financial sector in Southeast Asia, including investment and M&A, based in Malaysia.

He built his career at CIMB Group, one of ASEAN’s largest financial institutions, where he worked for 29 years before stepping down as chairman in 2018. Razak transformed CIMB from a local Malaysian investment bank into a leading financial group across ASEAN, expanding its assets nearly 1,000-fold and establishing a network of over 1,150 branches throughout Southeast Asia. He comes from a prominent political family in Malaysia, being the son of the country’s second Prime Minister, Abdul Razak Hussein, and the younger brother of the sixth Prime Minister, Najib Razak.



**Ashishkumar Chauhan**  
CEO of the National Stock  
Exchange of India

Founded the National Stock Exchange of India (NSE), which is responsible for the capital market of India, an emerging economic powerhouse, and is a leader who is shaping the future.

He played a pivotal role in modernizing India’s securities market by introducing the country’s first mobile trading system, establishing the SME equity market, creating the flagship Nifty index, and launching derivatives trading platforms. Chauhan is credited as the “father of modern financial derivatives in India” for his innovative work in developing India’s exchange-traded derivatives market. He is also a member of the University Grants Commission and serves as Chancellor of the University of Allahabad. Previously, he was the Group CIO at Reliance and CEO of the Mumbai Indians cricket team. Chauhan studied at IIT Bombay and IIM Calcutta.



**Anne Corona**  
CEO of Aon’s Enterprise Clients

An expert in consulting for large corporations in the global insurance market, she is recognized for her exceptional capabilities in corporate risk management.

She leads the strategic direction of Aon’s Enterprise Client Group, delivering integrated risk capital and human capital solutions to large multinational clients worldwide. With nearly 25 years at Aon, Corona has held several senior positions, including CEO of Asia Pacific, President of the Financial Services Group, and Chief of Staff in the CEO’s office. She is recognized for her entrepreneurial mindset and holistic perspective, helping Aon provide innovative solutions to its clients. Corona also chairs Aon’s Global Inclusive Leadership Council, advancing the company’s diversity and inclusion strategies.



**Marisa Chearavanont**  
Special Advisor to CP Group

Born in South Korea and naturalised in Thailand, she is a philanthropist, social entrepreneur, and patron of the arts.

She is married to Supakit Chearavanont, Chairman of CP Group, Thailand’s largest private company, and currently serves as Senior Special Advisor to the CP Group Chairman. Marisa is known for her passionate support of various social, educational, and cultural improvement initiatives. She founded the Chef Cares Foundation, which collaborates with Thailand’s top chefs to drive positive and sustainable social change through culinary arts. The foundation provides culinary education opportunities to underprivileged youth in Thailand and actively works to preserve and globalize Thai culinary culture.



**Anna Lembke**  
Author of “Dopamine Nation”  
Professor at Stanford University

A best-selling author and medical doctor who brought “Dopamine” to global attention.

The book has been translated into 35 languages and has sold over 200,000 copies in Korea alone. She emphasizes that a healthy life requires a balance between pleasure and pain in the brain. Lembke is a professor at Stanford University School of Medicine and heads the Stanford Addiction Medicine Dual Diagnosis Clinic. In her follow-up work, “Dopamine Detox,” she provides a step-by-step guide to practicing dopamine fasting, offering practical methods for achieving balance.



**Kurt Björklund**  
Chairman of Permira

He leads Europe’s largest private equity fund a renowned buyout firm specialising in corporate acquisitions and divestitures.

He became Co-Managing Partner in 2008, Managing Partner in 2021, and was appointed Chairman in 2024. Permira is recognized as a leading group in the global private equity industry. In 2024, it ranked 20th in the Private Equity International (PEI) 300 ranking. It was also placed among the top in the HEC Paris Dow Jones Global Buyout Performance Ranking. Permira actively invests across Europe, North America, and Asia, employing over 500 people in 16 cities worldwide. The firm manages approximately €80 billion (about 115 trillion KRW) and is renowned for its long-term investments in five key sectors: technology, consumer, healthcare, services, and climate.

**Ian Horrocks**  
Co-founder of Oxford Semantic Technologies  
Professor at Oxford University

Co-founder of Oxford Semantic Technologies and a professor of computer science at Oxford University, he is a leading authority on AI.

He is a fellow of the Royal Society, the European Association for Artificial Intelligence, and Academia Europaea. He is also a recipient of the Lovelace Medal, the highest honor awarded by the British Computer Society. Horrocks’s research focuses on enabling computers to understand and efficiently process knowledge. He pioneered the field of the semantic web, which transforms web information into a format that computers can interpret. He developed foundational theories, algorithms, and reasoning systems for the semantic web, and the inference software he created continues to be widely used in the field of artificial intelligence today.



**Chad Wolf**  
Executive Vice President of America First Policy Institute (AFPI)

He plays a key role in shaping and researching the policy agenda of the AFPI, widely recognized as the think tank closely tied to the U.S. President Donald Trump.

Prior to joining AFPI, Wolf served as Acting Secretary of the U.S. Department of Homeland Security (DHS), the third-largest federal department in the U.S. Government. During his time at DHS, he successfully navigated numerous global and domestic challenges to the nation’s security, including COVID-19, civil unrest, numerous border and immigration crises, historic natural disasters, and threats to global aviation security. Mr. Wolf is the Founder and CEO of Wolf Global Advisors (WGA), a strategic advisory and consultancy firm which focus on the homeland and national security markets.



**James Robinson**  
2024 Nobel Laureate in Economics  
Professor at the University of Chicago

Winner of the 2024 Nobel Prize in Economics, he is renowned for his research on the causal relationship between political systems and a country’s long-term economic performance.

He demonstrated, through works such as “Why Nations Fail,” that inclusive institutions lead to prosperity, while extractive institutions result in failure. In his latest book, “The Narrow Corridor,” he explores the conditions necessary for liberalism to take root within a state, arguing that freedom is only achieved when there is a balance of power between the state and the private sector; when this balance collapses, societies tend toward authoritarianism or anarchy. Robinson received his undergraduate degree from the London School of Economics, a master’s from Warwick University, and a PhD from Yale University inclusion strategies.



**John Mearsheimer**  
Distinguished Professor at the University of Chicago

A leading authority in the field of realist international politics, renowned for his exceptional ability to analyse hegemony.

In an academic environment dominated by liberal optimism after the end of the Cold War, he emphasized that conflict among great powers remains inevitable. According to his theory, great powers pursue hegemony sufficient to overwhelm their rivals, leading to a balance of power shaped by fear and calculation. He identifies the anarchic nature of the international system, states’ survival instincts, and military competition as the key variables. His major works include “The Tragedy of Great Power Politics” and “The Israel Lobby and U.S. Foreign Policy.” Mearsheimer interprets contemporary international issues such as the Russia-Ukraine war and cross-strait relations through a realist lens, greatly influencing experts in diplomacy and security.



**Herbert Diess**  
Chairman of the Supervisory Board, Infineon Technologies

Former CEO of the Volkswagen Group and current Chairman of Infineon, the world’s leading supplier of automotive semiconductors.

He began his career in the automotive sector at BMW in 1996, eventually serving as a board member. Later, he moved to Volkswagen, where he served as CEO of the passenger car division. He also chaired the audit committees for Volkswagen Group brands such as Skoda, SEAT, and Audi. Diess is recognized as a skilled executive, known for his exceptional preparedness and control in crisis situations. In addition to his global business expertise, he possesses deep insights into future industries such as electric mobility. He studied automotive engineering at Munich University of Applied Sciences and earned his doctorate from the Technical University of Munich.



**Edward Lee**  
Award Winning Chef & Author

A Korean-American chef and author who gained popularity on the Netflix series “Culinary Class Wars”.

Born in Seoul, he moved to the United States with his family as a child and spent his school years in New York. He studied English literature at New York University. Although he began his career at a publishing company, he quickly realized it wasn’t the right fit and started his journey as a chef at the age of 22. He rose to prominence after winning Season 8 of the popular American cooking competition show “Iron Chef America” in 2010. He currently operates several restaurants, including 610 Magnolia.

CEO of Rigetti Computing

An expert boasting over 30 years of experience in the semiconductor industry.

Since 2022, he has led the company’s commercialization strategy as its CEO. Rigetti Computing is a U.S.-based quantum computer startup.
